

## PET POLICY

As the privileged pet of my wonderful owner, I hereby agree to the following regulations and conditions while staying at La Casa del Zorro Resort:



I agree to **stay ON** a leash or in a carrier while in all public areas



I agree to **stay OUT** of all water features on the property (spa, pools, ponds, fountains, sprinklers, etc.).



I agree to **stay OUT** of all food and beverage areas (except for patio) and the workout facilities.



I agree to be with my owner while any associate of La Casa del Zorro Resort, such as Housekeeping or engineering, is in our room.



I agree to have my owner schedule daily housekeeping service at a time when we are out of the room.



I agree to refrain from noise or any other disturbance in the interest of other resort guests.



I agree to have my owner faithfully pick up & dispose of my personal duty appropriately (secure in plastic bag, twisted closed, and put in the trash bin).



**I agree that my owner will pay any additional cleaning bills or repairs should they be required. And my owner authorizes the resort to charge my owner's credit card for such charges, even if they are discovered after our departure from La Casa del Zorro Resort.**



I agree that, should I create any disturbances which cause complaints to be made to La Casa del Zorro by other resort guests or resort associates, at the request of the management, my owner will make immediate arrangements for me to stay elsewhere.

**I understand that there is a one-time non-refundable charge of \$50 for visits of up to 3 nights for me (this does not include additional cleaning charges, etc.).**
